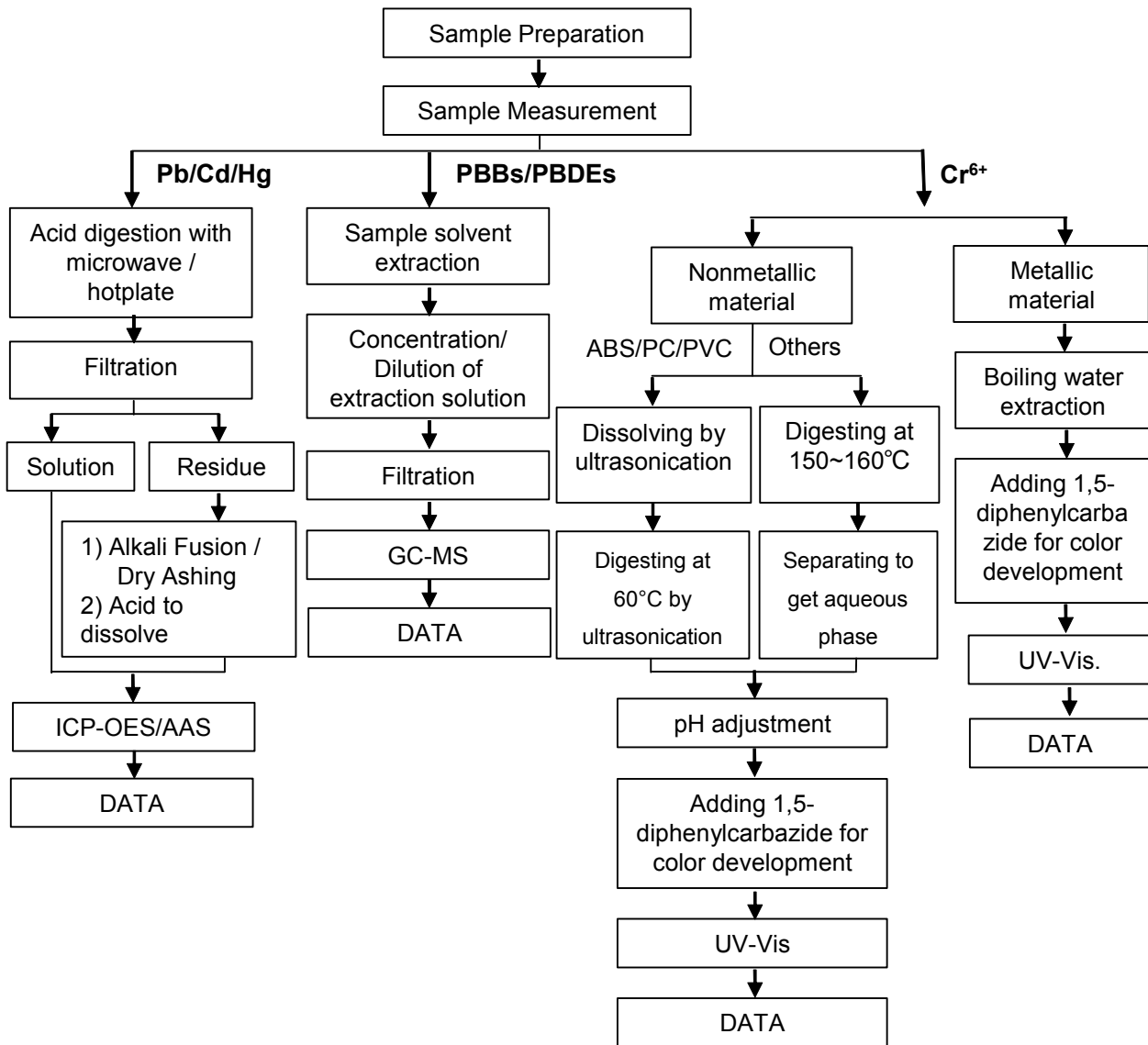

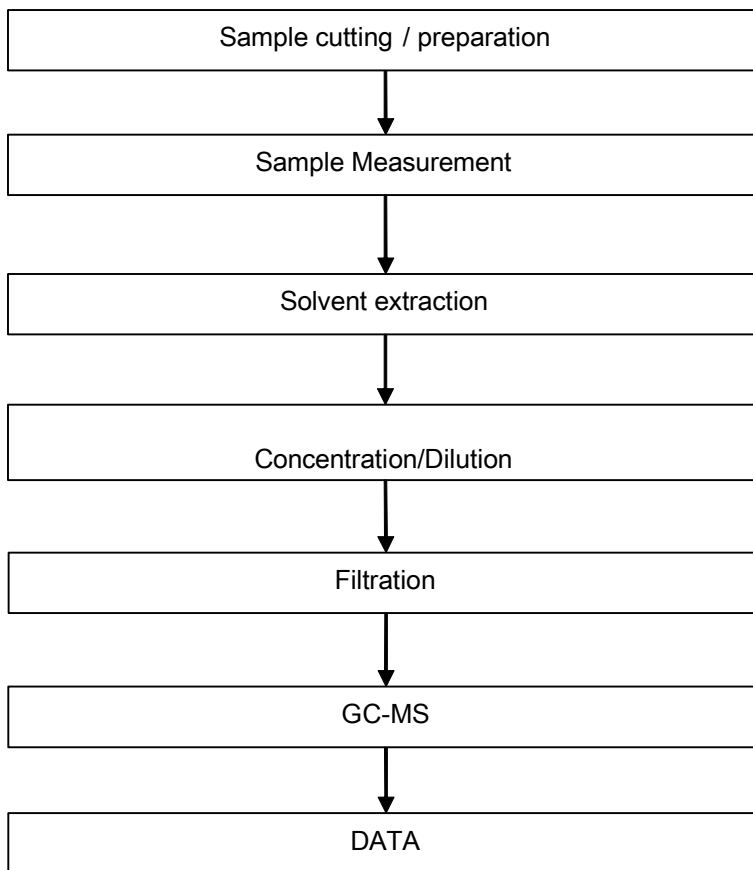

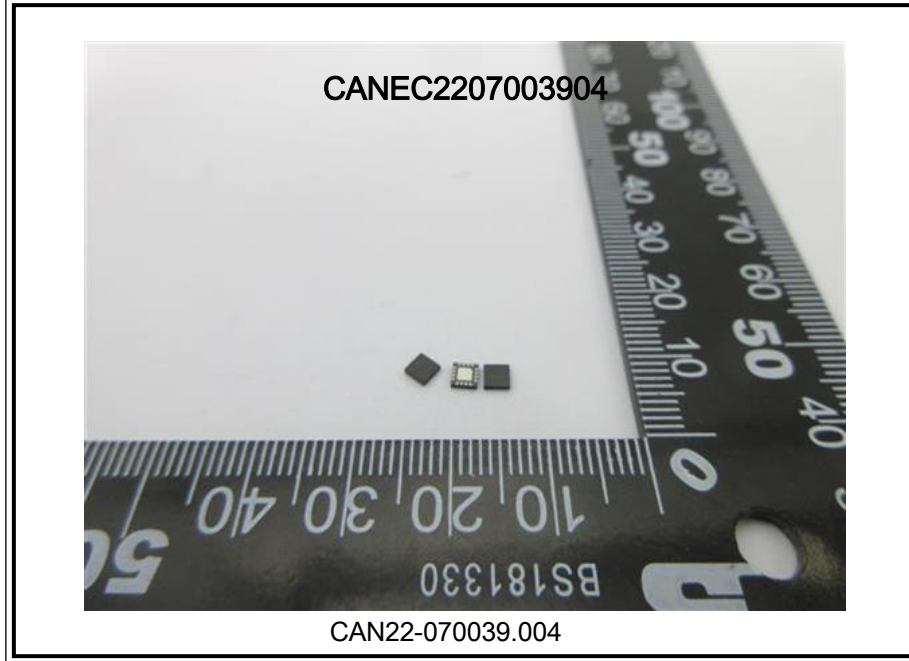
Phthalates Testing Flow Chart
